

LCC COVID Liability Waiver

1. I have read and affirm the Lake Community Church (LCC) Sick Child Policy.

LCC SICK CHILD POLICY

Sick children will not be allowed in the nursery or LCCKids or LCCStudent ministries. Please make sure your child is free from diarrhea, runny nose, fever, vomiting, and any contagious disease for at least 24 hours. If the child is being treated with antibiotics, he/she should be on the drug for at least 24 hours before coming to LCC¹. A child with a runny nose that is yellow or green will not be accepted. Please understand if the LCC volunteer refuses to accept your child if they appear to be sick; we are doing this to try to protect the health of all children. If your child is brought to ministry service and they are ill, you may be asked by the staff to keep your child with you (or in the case of COVID to leave the church premises). While it may not seem like a serious illness to you, remember there are many other children that could potentially become ill after being exposed to your child's illness. Thank you for partnering with us as we strive for all our babies, toddlers, children, and teens to remain healthy and happy.

2. I am aware that COVID-19 is highly contagious and is known to spread mainly from person-to-person contact.
3. I acknowledge the contagious nature of the Coronavirus/COVID-19 and that the CDC and many other public health authorities recommend practicing social distancing.
4. I further acknowledge that Lake Community Church has put in place preventative measures to reduce the spread of the Coronavirus/COVID-19 but cannot guarantee that I, or my child, will not be exposed to Coronavirus/COVID-19.
5. I give permission for Lake Community Church to screen my child's temperature before being allowed to participate in church ministries.
6. I acknowledge that the nature of many church activities [including but not limited to singing, serving others, and playing games] makes it impossible to observe all of the recommended precautions at all times; for example, individuals may not always be six feet apart, and surfaces cannot always be ensured to be sterile despite our best efforts. As a result of participation in the activities of the ministry and proximity to other participants, you or your child may be exposed to the risk of infection of communicable diseases, including COVID-19.

7. I voluntarily agree to allow my minor children to participate in services provided Lake Community Church and acknowledge that I may be increasing my risk to exposure to COVID-19.
8. I assume the same liability for any minor child that I bring to Lake Community Church.
9. By attending Lake Community Church, I agree to abide by the procedures established by the church to protect attendees and staff, and I voluntarily assume the risk that I, my family, and any other minor individuals that accompany us may be exposed to or infected by COVID-19 either at the church, in the church worship service, or in the nursery, or other ministry venues. I agree to assume all the risks of attendance and participation for myself and my family, and I waive any liability against the church and any other parties.
